- Copy of JV agreement (in case of JV) must be attached.
- Municipal Rates & Taxes Clearance Certificate not older than 90 days or a lease agreement must be attached.
- In case of a JV Municipal Rates & Taxes Clearance Certificate not older than 90 days or a lease agreement of all parties must be attached.
- All supplementary / compulsory forms contained in the bid document must be completed and signed in full.
- Bidders will only be allowed to submit one bid document per bid (either as a joint venture or individual company not both).
- Failure to comply with the above mentioned conditions will invalidate your bid.
