# REPORT ON THE PROCESS OF ESTABLISHMENT OF WARD COMMITTEES FOR MANGAUNG METRO

#### 1. Purpose

The purpose of the report is to give account of the process of establishment of Mangaung Metro Ward Committees for the Council term 2016 to 2021. It will deal with the process from advertisement stage, nominations and the actual elections.

#### 2. Introduction

Below are the steps that were embarked upon for the process of the establishment of Ward Committees. The process commenced with the workshops for Councillors, and the entire task team that comprises of internal staff-members and Community Development Workers.

Ward Committees are structures meant to give effect to community participation as contained largely in the following national legislations, namely, the Constitution, Structures Act and Systems Act as well as the Mangaung Metropolitan Municipality internal policies.

Municipal System Act defines a municipality as consisting of political structures and administration on the one hand and the community on the other. In essence, the community is represented by the elected Ward Committees in the Municipality hence a need to establish formal ways to ensure their legitimacy and active participation.

Concomitantly, the Constitution of the Republic of South Africa states the objects of local government amongst others as (a) to provide a democratic and accountable government to local communities and community organizations in the matters of local government.

#### 3. Legislative framework

In terms of Section 72 of the Municipal Structures Act, No. 117 of 1998, a metropolitan or local municipality of a type that include ward participatory system may establish ward committees for all their wards. Ward Committees are established mainly to enhance participatory democracy in local government. They are a municipal structure that must afford the ordinary members of the community an opportunity to influence the decisions of the elected public representatives. In other words, they must ensure that the concerns and views of the community are heard by those that must take decisions.

On the other hand, Section 73 of the same Act provides guidelines on the composition of a Ward Committee. It provides that each ward committee will consist of the Ward Councillor, who must also be the chairperson of the committee and not more than 10 other persons. Municipalities are further urged to make rules and guidelines regulating Ward Committee and they must deal with amongst others the following matters:

- a) The procedure to elect the 10 members taking into account the need for equitable representation of women and the diversity of interests in the ward.
- b) The circumstances under which those members must vacate office
- c) The frequency of meetings.
- d) And any other matters.

The legislation does not deal with the details regarding procedural or operational matters of the establishment and operation of Ward Committees. Municipalities working together with the Department of Cooperative Governance and Traditional Affairs (Cogta) are expected to develop and implement guidelines and policies around those matters. Cogta has developed the guidelines for Municipalities and the document was duly provided to all municipalities for use during the upcoming process of establishment of Ward Committees.

Lastly, the System Act dictates that the municipality must develop a culture of municipal governance that complements formal representative government with a system of participatory governance and must encourage and create conditions for the local community to participate in the affairs of the municipality. The municipality must also

develop mechanisms, processes and procedures for community participation and communicate to its community and stakeholders such information concerning available mechanisms, process and procedures.

#### 4. The role of a Ward Committee

In line with the above legislative provisions, Ward Committees are established to highlight Mangaung Metro's commitment to a form of governance that affords local communities, stakeholders and interested parties a platform to contribute effectively to the broader transformational and developmental agendas in the municipal area.

The role of Ward Committees in Mangaung is to assist with the implementation of those matters as contained in Section 2 of the Constitution for Ward Committees. Amongst others, the Ward Committees are to serve as a formal representative structure for their own local communities in the Municipal area. They are expected to work closely with and support the Ward councilor in the execution of his/her responsibility in wards and in the clusters.

#### 5. Elections Roll-out plan and activities

#### 5.1 Consultation with Councillors

Consultation with Councillors took place on the 18<sup>th</sup>January 2017. The purpose of that consultation was to achieve the following two aspects;

- To workshop Councilors on the establishment of Ward Committees.
- To agree with Councillors and how the process should unfold. The objectives set out for the meeting were indeed achieved and common understanding was achieved.

#### 5.2 Consultation with the elections task team

As part of the people who are rendering work at the ward level and being officials responsible to support Ward Councillors, the office organized a meeting on the 18th January 2017 to brief the election task team about the process of the establishment of Ward Committees. The meeting further discussed the role that election task team were expected to play during the advertisement period and information sessions to be held by Councillors in their respective wards.

#### 5.3 Special Council meeting to approve guidelines

A Special Council meeting of the 09th November 2017 was convened to receive and

approve the Guidelines on Establishment and Operations of Ward Committees. The meeting further approved the dates for information sessions that Councillors were required to hold in their respective wards.

Council resolved that elections would be held on 16th February 2017.

#### 6. Information sessions in different wards

As part of communication and advocacy, Ward Councillors were issued with a schedule to hold information sessions in their wards wherein they were expected to introduce the process of elections of Ward Committees to the broader public and other stakeholders at ward level. These information sessions were held during the period 15<sup>th</sup> & 16<sup>th</sup> February 2017.

#### 7. Publicity and awareness

To ensure that there is wide-spread distribution of information to all members of the public, the office placed newspaper advertisements in the local media. The first advertisement related to the nomination process and the second one to the election dates, venues and times in the different wards.

7.1 The advert that was placed in all local media to give notice to the public and inviting them to apply and were to acquire the nomination forms were placed in the following newspapers.

#### 1. What is a Ward Committee?

Ward Committees are voluntary bodies established by municipalities in terms of Part 4 of Chapter 4, Sections 72 to 75 of the Municipal Structures Act, No. 117 of 1998. They are established to assist and work with the Ward Councillor to amongst others do the following;

- a) Express the needs and concerns of the residents within the ward.
- b) Identify development priorities within the ward.
- c) Promote and facilitate interaction between the Council and the community in particular ward.
- d) Respond to the concerns of the residence within the ward.
- e) Involve the residents in the ward in identifying and prioritizing needs.

#### 2. Criteria for people who may stand for elections:

A person is eligible to be elected as a Ward Committee member if he/she complies with all of the following requirements:

- a) He/she must be at least 18 years or older.
- b) He/she must be a South African citizen with a bar-coded identity document.
- c) He/she must reside in the specific ward that he/she is availing himself/herself to be elected.
- d) He/she must be a registered voter in the specific ward that he/she is availing himself/herself to be elected.
- e) He/she must not have a criminal record or has been convicted of an offence and sentenced to imprisonment without the option of a fine for a period of not less than twelve months.
- f) He/she must be properly nominated in accordance with the procedure set by the Municipality.
- g) He/she is not the employee of the Mangaung Metropolitan Municipality.
- h) He/she must not be of unsound mind or have been declared so by a competent court of law.
- i) He/she must be active in the sector they represent and should be motivated to work on the ward committee by their desire and commitment to working for a better life for their constituency or community.

# 3. To qualify for elections, the nomination of each candidate must meet the following procedure:

- a) A candidate can only be nominated by another person who is eligible to vote in the election of that specific ward.
- b) A candidate's nomination must be signed by the nominator and seconded by twenty (20) other persons who are eligible to vote in the election of that specific ward.
- c) The candidate can only be nominated by means of a prescribed form issued by the Municipality.
- d) The nomination form must specify the sector or geographic area that the nominee represents.

#### 4. To be able to participate in the elections, a person must:

- He/she must be at least 18 years or older on the date of the election.
- He/she must be a South African citizen with a bar-coded identity document.
- He/she must reside in the specific ward that he/she is availing himself/herself to be elected.
- He/she must be a registered voter in the specific ward that he/she is availing himself/herself to be elected.
- He/she must not have a criminal record.

#### 8. Electoral Staff/Facilitators

Due to the fact that the elections were conducted in 49 wards in exclusion of ward 39 with other wards having more than one voting station (vd), the Office of Speaker

requested assistance from other Directorates with regard to personnel. This is because on its own and with the few staff members in the office, it would not be in a position to run the elections successfully. Therefore a team of 160 Facilitaters was assembled. These were municipal staff and CDWs. They were given an orientation on the Rules and Procedural Manual for the Establishment and Operation of Ward Committees. The orientation took place over a period of two (2) days.

#### 9. Nomination process

Provision is made in the Procedural Manual for any member of the community to object nomination of any prospective candidates. This could largely be attributed to time constraints. The prospective candidates' lists were not made public before printing of ballot papers. Administratively all forms were scrutinized, rectified and verified in a secured elections room.

Eventually the ballot papers were printed and we proceeded with the elections.

#### 10. Elections (16th February 2017)

The elections took place on the 16<sup>th</sup> February 2017 they were held in 49 wards of Mangaung. As indicated, other wards where the elections were not successful due to disruptions a new date is yet to be announced by the Speaker.

For the purpose of this report, this section will give the details with regard to three (3) scenarios:

- Wards where elections went ahead with only ten nominations.
- Wards where elections went ahead without problems.
- Wards where there were challenges and/or disruptions.

The following wards had elections with only ten nominations, therefore all those 10 nominees qualified to be declared duly elected members.

These are the following four (4) wards:

#### 10.1 Wards where elections took place without challenges

Elections in the wards mentioned below took place without incidents or challenges such as objections or disruptions. In most of them people turned up in good numbers to cast their votes. The election procedure were duly followed and counting was done.

#### 10.2 Affected Wards

The elections in the wards under this section did not take place on the 16<sup>th</sup> February 2017 due to various challenges encountered. Other challenges were characterized by unruly members of the community.

Subsequent to submitting the report to the Speaker on what had transpired in each ward, he consulted with all Councilors and a consensus was reached on a second round of elections in those affected wards. The date of the elections will be determined by Council.

The following section will deal with the challenges encountered on the 16<sup>th</sup> February 2017.

#### 10.2.1 Details of problems and/or disruptions

#### Ward 4

- > The elections were conducted and the following were concerns raised:
  - It was discovered that some of the candidates' names did not appear on the ballot paper.
  - Community members wanted the facilitators to read out the names of the people on the ballot paper before they elect as they were accusing the councilor of calling those who were on the ballot paper prior to the election and he only put the favorite ones only on the paper they claim their names was taken out by the councilor.
  - o Facilitators tried to call the councilor as he was not at the venue but his phone was off.
  - As a result, a decision was made that there elections would be called off.

#### Ward 6

- ➤ Elections were disrupted by few individuals who claimed that they were not informed about the elections and they want a report from previous ward committee members and that within 2minutes the facilitators must be out of the venue.
- > As a result, a decision was taken that the elections be called off.

#### Ward 10

- > When the Facilitators arrived at the venue for the elections they were told by community members that they don't want to vote therefore no elections will take place.
- > They claimed that they did not know the people on the ballot paper and they needed postponement.

- > Facilitators arrived late due to limited transport.
- There was dissatisfaction by ANC volunteers who alleged that their names were removed.

> As a result, a decision was taken that the elections be called off

#### Ward 17

➤ Facilitators on arrival found the venue closed because the priest of the church claim EFF members called him and threatened to burn the church if he allows the elections to continue. It was felt that there was pending danger and threat to the lives of the facilitators and community members hence the elections were called off.

#### Ward 31

- ➤ Some community members claimed that the ballot paper was changed as they have another ballot paper and wanted the people who were on the ballot paper that they are in possession of ,other members wanted to continue but the others felt they wanted an explanation on the issue of different ballot papers.
- > Facilitators felt unsafe and called off the elections

#### Ward 32

- > When facilitators arrived at the venue there were already disruptions as there were people swearing and singing outside the venue.
- > As soon as they were about to start with the process of voting a group of EFF members stormed the hall throwing chairs, tearing the ballot papers.
- > It was felt that there was pending danger and threat to the lives of the Facilitators and other community members hence the elections were called off.

#### Ward 35

> Facilitators came and the community felt unsafe because of gangsterism in their area therefore elections in this ward were called off.

#### Ward 41

> Facilitators arrived late at the venue because of the heavy rains,

- > Community members said the councilor did not inform them about the elections and they wanted the names of those shortlisted to be placed on all convenient places for them to see prior to election
- > The venue was not sufficient enough to cover all villages.
- > The election was cancelled.
- Ward 47
  - ➤ When Facilitators arrived at the election venue they were told by the ward councillor Clr De Bruin that the elections won't continue without a voter's roll then the election was called off by the councillor.
- Ward 50
  - ➤ Elections were supposed to be held in three vd`s wherein only one in Wepener had elected successfully. The two other vd's therefore form part of the wards legible for re-elections.

#### 11. Conclusion

In conclusion, it was noted that in the wards falling under the first two categories, i.e. where there were only ten nominations and where elections were conducted smoothly, the results would be valid and stand.

However, were the problems and/or disruptions, those wards will go for another round of elections. Soon thereafter, the Speaker will announce the results of elections of those that were run smoothly and the re-run ones will be announced at a later stage. Attached hereto is the final list of the elected ward committees marked annexure "A".

#### 12. Recommendations

It is therefore recommended that:

14.1 Council approves the report of the elections of ward committees as contained in the attached list.

- 14.2 The report and list of elected members should be submitted to the Department of Cooperative Governance and Traditional Affairs.
- 14.3 Induction and training for elected ward committees should be conducted as soon as possible.
- 14.4 Council mandates the Speaker to work with the affected ward councillors to find a solution of possible re-run and establish ward committees in the 11 outstanding wards, which are 04, 06, 10, 12,17,31,32,35,41,47 and 50.
