## MAYCO COUNCIL

TABLING OF MANGAUNG METROPOLITAN MUNICIPALITY REVIEWED DRAFT INTEGRATED DEVELOPMENT PLAN (2018/19) FOR NOTING

#### **PURPOSE**

To table the reviewed draft Integrated Development Plan (IDP) for 2018/2019 financial year for noting.

### **Background**

According to the Municipal Systems Act (No. 32 of 2000) section 34, subsection (a) the municipality must review its integrated development plan-

- annually in accordance with an assessment of its performance measurements in terms of section 41; and
- ii. to the extent that changing circumstances so demand; and
- (b) may amend its integrated development plan in accordance with the prescribed process.

Chapter 5 of the Municipal Systems Act (MSA) provides valuable guide on how to develop the IDP. Section 21 stipulates that each municipal council must, within a prescribed period after the start of its elected term, adopt a single, all inclusive and strategic plan for the development of the municipality as a whole.

The Municipal Systems Act, as well as the Municipal Finance Management Act, No 56 of 2003 confer the responsibility on the Executive Mayor to provide political guidance over the development of the IDP and the budget processes, and to identify priorities that must guide the preparation of the annual budget. In compliance with this legislative imperative, the drafting of the IDP has taken into account political priorities as expressed by the Executive Mayor.

A MAYCO Lekgotla was convened on 19th January 2018 to review progress and discuss development priorities for the City.

The law further provides that the process of drafting IDP should be consultative, participative and aligned with development priorities of communities and other spheres of government. In line with this requirement, the Municipality has strengthened this by ensuring that all the Councillors' reports per ward as consolidated by office of the Chief Whip and Speaker; are scrutinised to verify that the community issues which were raised and captured in the current (2017/18 IDP) are still valid.

#### Recommendation

It is recommended that Council

- 1) Notes the reviewed draft IDP 2018/19 for Mangaung Metropolitan Municipality;
- 2) Notes the Sector Plans as follows:
  - o Draft Spatial Development Framework Chapter 5
  - Draft Local Economic Development Chapter 8
  - Draft Integrated Human Settlement Plan Chapter 8
  - Draft Climate Change Adaptation and Mitigation Strategy Chapter 8
  - Integrated Waste Management Plan Chapter 8, previously approved by council
  - o Water Services Development Plan Chapter 8, previously approved by council
  - Ten Year Water Conservation and Water Demand Management Strategy Chapter 8, previously approved by council
  - Disaster Management Plan Chapter 8, previously approved by council
  - o Integrated Public Transport Network Plan Chapter 8, previously approved by council
- 3) Notes that copies of the reviewed draft IDP 2018/19 will be forwarded to provincial and national departments of Treasury and Co-operative Governance and Traditional Affairs
- 4) Notes that the reviewed draft IDP will be published on the website and newspapers for comments; and
- 5) Notes that the public participation meeting on the draft IDP in line with the approved 2018/19 IDP and Budget Process Plan will be embarked on. (Refer to the attached annexure on the Approval Phase of the IDP and Budget Process Plan)
