1. PURPOSE

2. BACKGROUND

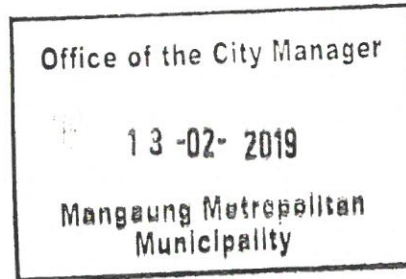
