**REPLACEMENT AND FILLING OF VACANCIES IN THE MUNICIPAL COUNCIL**

**1. PURPOSE**

The purpose of this report is to appraise the Municipal Council on the replacement and filling of vacancies in the Council.

**2. BACKGROUND**

Proportional Representative (PR) councillors are elected on a party list system. A party, having secured a certain number of seats on the council in the municipal election, fills those seats by nominating members through its party list. A PR councilor who is no longer a member of the political party make way for new member nominated by the party.

The guideline stipulates that, when the Municipal Manager becomes aware of a PR vacancy in the council, he or she must inform the IEC. This must be done within seven days after the councilor loses party membership. The IEC the allows the party time in which it may change the party list. The party list contains the names of party members who are not yet in the council. In line with the provisions in item 18 of schedule 1 of the Municipal Structures Act, 1998 (Act No. 117 of 1998) , the IEC declares the person named at the top of the party list elected as councillor.

**3. DELIBERATIONS**

Two proportional vacancies existed in the Municipal Council. These two vacancies came as a result of the members ceasing to hold office. The first vacancy from the Economic Freedom Fighters (EFF) came as a result of the former councilor TK Mapitse passing away on the 04<sup>th</sup> August 2019. Mr. MMP Tsiane (550719 5540 082) being the candidate at the top of the party list of the EFF and declared elected effective from 03<sup>rd</sup> October 2019.

The second vacancy from the African National Congress (ANC) came as a result of the former councilor SG Kaliya passing away on the 14<sup>th</sup> August 2019. Ms. BNV Madela (810913 0940 084) being the candidate at the top of the party list of the ANC and declared elected effective from 11<sup>th</sup> October 2019.

## 5. RECOMMENDATIONS

It is hereby recommended that the Municipal Council take note of the election of Mr. MMP Tsiane and Ms. BNV Madela as duly elected Council members.
