# APPROVAL OF INDIGENT ACCOUNTS FOR INCLUSION IN THE 2019/22 INDIGENT REGISTER (SECOND BATCH)

### PURPOSE

To obtain approval to register the households qualifying as indigents in the Council's indigent register for the 2019/20 to 2021/22 MTREF

### 2. BACKGROUND AND DISCUSSION

Mangaung Metropolitan Municipality embarked on the process of compiling the 2019/22 and updating the 2017/18 **Indigent Register** to ensure implementation of Free Basic Services to deserving and qualifying poor households in line with the Council approved Indigent policy.

Indigent policy was reviewed and adopted by Council in May 2019 and stipulates that all households with total/ combined monthly income of less than three state pensions (R 5 400) for all persons over 18 years old, qualify and will benefit from indigent subsidy on municipal services.

#### QUALIFICATION CRITERIA UTILIZED

Qualification criterion for indigent was applied as determined in the Indigent Policy approved by Council:-

- ♣ The applicant must be a resident within the Mangaung municipal area (Municipal account was used as a proof).
- The applicant must be in possession of a valid South African identity document (Copies of the Identity documents were utilized).
- The total monthly gross income of the registered owner/ tenant and his/her spouse or life companion is not more than three state pensions (5 400). This amount includes any rental received from other occupants on the stand as well as 5% of the gross income of any child and his/her spouse or life companion residing on the stand (Proof of the income of all occupants on the property; i.e. a letter from his/her employer, salary slip/ envelope, pension card, unemployment insurance fund (UIF) card or a certificate that confirms registration as "looking for employment" and affidavits).
- The applicant must be the owner or tenant who receives municipal services and is registered as an account holder on the municipal financial system;
- Any occupant or resident of the single household referred to above may not own more than one property in addition to the property in respect of which indigent support is provided.
- A tenant can only apply for the benefits in respect of the charges he/she is billed for while the landlord remains liable for all ownership related charges such as rates.
- The current account of a deceased estate may be subsidised if the surviving spouse or dependants of the deceased who occupy the property, applies for assistance

#### THE EXTENT OF INDIGENT SUPPORT

Indigent households have to be granted access to a full social package, assistance and support as set out below:-

### **Electricity**

- 4 All registered indigents will receive 50 kWh of electricity per month fully subsidised
- Unused free electricity units will not be carried over to the next month.

#### Water

- All registered indigents will receive 6 kilolitres of water per month fully subsidised.
- 4 Any excess to the abovementioned kilolitres will be charged to the consumers

#### Sewerage

4 All registered indigents shall be fully subsidised for sewerage levied.

#### Refuse Removal

4 All registered indigents shall be fully subsidised for the basic levy for refuse removal.

### Property Rates

All registered indigents shall be fully subsidised for the basic levy of property rates.

### **Burials**

The indigent burials shall administered by social services departments

## 2.3 Applications without municipal accounts

8 317 do not have services accounts with the municipality but they have prepaid electricity meters with Centlec. Thus, the customers are considered to be indigent and qualify to obtain free electricity.

64 applications are housing rental accounts, thus the customers are considered to be indigent and qualify to obtain free electricity.

## 2.5 Applications not recommended in the 2019/2022 registration process

- 9 750 applications were received and it was established that the applicants do not qualify to be included in the indigent register due to the following reasons:
  - Applicant deceased, beneficiary must reapply.
  - Above the threshold
  - Valuation Roll Property category business

# 4. FINANCIAL IMPLICATIONS

- 1. An amount of R 221 674 052.54 for 15 912 indigent accounts to be written off and provided with 6 Kilolitres of water monthly (Annexure A and Annexure A2).
- 2. 8 317 applications will be provided with 50 kWh of electricity monthly (Annexure B and F).
- 3. That 64 rental housing indigent account to be provided with 50 kWh of electricity monthly (Annexure C)

## 5. RECOMMENDATIONS

- 1. That the council approves the **21 007** applications for inclusion in the 2019/2022 indigent register and are provided with free basic services as stipulated in the indigent policy.
- 2. That the council approves the **8 317** applications for inclusion in the 2019/2022 indigent register and are provided with free 50 kWh of electricity monthly.
- 3. That council write off the R 250 358 067.38 owed by 29 324 indigents.
- 4. That the 64 housing rental be provided with 50 kWh of electricity monthly.
