**Note by Secretariat**

Members are requested to fill in this register 12 hours before the commencement of the meeting (Rule 22.2) (Yellow Form).
3. **Name-plates:** Councillors are friendly requested to please take along their name-plates and to display it throughout the meeting.
4. **Apologies during the course of the Council meeting:** Councillors are friendly requested to complete in full and submit the relevant apology form for this purpose (Yellow Form).
5. **Code of Conduct:** Councillors are reminded of item 3, Schedule 1 of the Code of Conduct for Councillors which reads as follows, namely:

Attendance at Meetings: A councillor must attend each meeting of the municipal council and of a committee of which that councillor is a member, except when:

- (a) leave of absence is granted in terms of an applicable law or as determined by the rules and orders of the council or
- (b) that councillor is required in terms of this Code to withdraw from the meeting.

**6. Meeting rules:**

- i. All Councillors must arrive at **least 15 minutes before the commencement** of the Council and all other Committee meetings;
- ii. Cellular phones **must be in silent mode** and **speaking on a cellular phone during the meeting is prohibited**; (Rule 50.2a)
- iii. A Councillor who speaks must **confine his or her speech strictly to the matter under discussion**; (Rule 31)
- iv. Unless expressly otherwise determined, a Councillor **may speak only once on a matter**; (Rule 32)
- v. No speech shall exceed **five (5) minutes** in length without the consent of the Speaker. (Rule 34.1)
- vi. Council members are reminded to uphold high level of good conduct during Council proceedings (No disruptions, no interruptions, no howling, no swearing to other Council members, less movement in the Chamber, no abuse of the PA system).

**DECLARATION/ANNOUNCEMENT OF VOTES ON THE MOTION OF NO CONFIDENCE AGAINST THE EXECUTIVE MAYOR, COUNCILLOR SM MLAMLELI RECIVED FROM THE FREEDOM FRONT PLUS**

**The Speaker remarked:** "Councillors, I must just that last week we had a Council meeting where all political parties were present when we were counting. I also asked political parties to accompany the ballots. Some they did and those ballots were counted here.

Let me reprimand Councillors because the Speaker did not announce yet but yet went out and spoke to the media and as a result, the results I am going to read here, every-body knows. Please you must not do this again. It must be the last time.

I will the announce the results: in favour of the motion **is 31 votes; against the motion is 28 and the spoiled papers is 8.**

This has implication; I am sure you know that the first Council meeting, this Council elected the Speaker, the Chie Whip, the Deputy Executive Mayor and the Executive Mayor as well. It the simply means that the Deputy Executive Mayor has responsibilities in case that the Executive Mayor not available.

The Deputy Executive Mayor will act in case the position of the Executive Mayor is vacant. It simply means that the Deputy Executive Mayor will act from today.

Secondly, we are going to convene, and we are going to look at our Rules and then quickly convene a Council meeting that will elect the Executive Mayor. For now...I am saying, the first Council meeting we elected the Speaker, Executive Mayor, the Deputy Executive Mayor and the Chief Whip. The Deputy Executive Mayor's duties, when the Executive Mayor is not available and when the position of the Executive Mayor is vacant, the Deputy Executive Mayor is going to act. So, he is going to act until such time that we elect the Executive Mayor.

We are going to look at our Rules and ensure that the position is going to be filled as soon as we call another meeting. The Speaker is going to convene a meeting. My duty today is just to announce the results. Thank you, Councillors."

**Councillor BJ Viviers remarked:** "Mister Speaker, will you also re-elect the Executive Committee in terms of the four of the Municipal Structures Act. If you can just give us guidance. Thank you, Mister Speaker."

**The Speaker responded:** "When the Executive Mayor is not there like in this situation, obviously the Mayoral Committee is disbanded and so the Deputy Executive Mayor will do what he is expected to do."

*It was thereupon with **31 votes in favour of the motion; against the motion is 28 and the spoiled papers is 8.***

**RESOLVED**

1. that the motion of no confidence against the Executive Mayor, Councillor SM Mlamleli was *approved by Council*;
2. that the Deputy executive Mayor, Councillor LA Masoetsa will resume the functions and duties of the Executive Mayor until such time that Council elect the Executive Mayor and
3. that the Mayoral Committee was disbanded until such time the that Executive Mayor appoint the Committee members.
