PREPARATIONS AND ARRANGEMENTS FOR THE FUNERAL OF THE LATE COUNCILLOR EDDIE KOLLIE GOLIATH.

1. PURPOSE

The purpose of the report is three-fold, namely:

- To inform the Municipal Council on the unexpected death of the EFF PR Councillor EK Goliath.
- To request the Council to declare the Funeral of Councilor EK Goliath as Civic Privileges Funeral and
- To request the Municipal Council's approval of the cost that will be incurred as well as the facilities for the funeral arrangements of the late councilor.

2. BACKGROUND

The City and Community of the Mangaung learned of the untimely death of the councilor, on the morning of the 06 May 2021.

The councilor was admitted at hospital and he had complications that led to his unfortunate and sudden departure.

The Council contribution of the Councilor EK Goliath commenced during the 2016 to the 06th May 2021 during that time he was the EFF PR councilor and served in the following committees as a member of, Section 80 Finance,IDP & Performance Management & Section 79 MPAC(Municipal Oversight & Public Accounts and Remunerations Committee.

3. FUNERAL ARRANGEMENTS AND PREPARATIONS

In honor of the late Cllr EK Goliath, Council undertakes to work with the family to ensure that he receives a befitting send off for a hero of his stature. The date of the funeral service will be announced in due course, once the family, and Council have met and reached agreement on the logistical arrangements, the date, time and venue of both the memorial service and funeral will be made known to the members of Council.

In anticipation of the MMM to accord the Civic Funeral Privileges to Councilor EK Goliath, The MMM will work closely with the family to ensure that all logistical arrangements and preparations are concluded timeously.

4. ROLE OF DIFFERENT DEPARTMENTS / OFFICES

OFFICE OF THE SPEAKER

The following are the required arrangements, namely:

- provision of PA system
- drafting of the programmes for the memorial service
- issuing of invitations towards the memorial service
- flower bouquets, on behalf of the City
- branding material in the venues
- designing and printing of funeral programmes.
- catering
- decoration for the venues (memorial services and funeral)
- Logistics arrangements regarding parking and traffic control.
- Use of the fire engine to transport the body to the graveyard.

5. ADMINISTRATIVE AND LEGAL IMPLICATIONS

Civic Funerals for serving councillors as well as the distinguished members of the community have serious financial implications, as the service attracts and involve many mourners for whom the following should be in place, namely:

- Catering for mourners at the funeral;
- contributing a venue for the memorial service and funeral service and related logistical requirements should such a need arise;
- jointly with the family and the Office of the Speaker, who is the custodian of Council.

1. CONCLUSION

That the approval of this report will contribute in ensuring a decent sending off for the late Councillor EK Goliath.

2. RECOMMEDATIONS

- (a) that Council approves the report;
- (b) that approval be granted to accord Civic Funeral Privileges to the late Councillor EK Goliath.
- (c) that an amount of R100 000,00 be set aside for all funeral requirements, including memorial service costs.
- (d) That the council approves the use of council facilities and other logistical arrangements as indicated under paragraph 4 and 5.
