1. PURPOSE AND SCOPE

The purpose of this document is to request Council approval of the Oaths of Office which must be administered to the Metro Police Officers in terms of the provision of Regulation for Municipal Police Services of 1999 by the Metro Police Commissioner (MPC).

2. OATH OF OFFICE

All department members, when appropriate, shall take and subscribe to the oaths or affirmations applicable to their positions.

If a member is opposed to taking an oath, he/she shall be permitted to substitute the word "affirm" for the word "swear."

3. LANGUAGES OF OATH OF OFFICE

The Oath of Office will be administered to the members by the Commissioner of Mangaung Metropolitan Police Department.

4. REGULATION PROVISION

In terms of regulation paragraph 11(1)(j) of Municipal Police Service, Government Gazette 20142 of 1999, regulate the taking of Office Oath by Metro Police Officers determined by Council. The Mangaung Metropolitan Police Department will, when appropriate, affirm / swear the oath of office as an expression of commitment to the constitutional rights of those served by the Department and the dedication of its members to their duties.
