1 PURPOSE

To obtain approval of the Unauthorized, Irregular, Fruitless and Wasteful Expenditure (UIFWe) Reduction Plan/ Strategy.

4 BACKGROUND AND PROGRESS MADE TO DATE

The Auditor-General has highlighted an escalating trend in unauthorised, irregular, fruitless and wasteful expenditure for Mangaung Metropolitan Municipality over

recent years, and the details of the UIFWe were summarised in the Annual Financial Statements of the municipality.

The 2020/21 Annual Financial Statements reflects the following:

Council had already referred all the UIFWe for 2019/20 and prior financial years to Municipal Public Accounts Committee for further handling and investigation in line with MFMA Circular 68.

To date, the municipality is currently performing an investigation through the Intervention Team as support structure to the MPAC and the progress report will be submitted to Council in the second quarter of the 2021/22 financial year.

Most of the items in the Unauthorized Expenditure relates to non-cash items like Depreciation and Debt Impairment. Furthermore, the Irregular Expenditure was increased by the misinterpretation of Supply Chain Management Regulations in relation to composition of the Bid Adjudication Committee. All these matters are part of the Reduction Plan reflected on Annexure A of this report.
