THE SPEAKER COUNCIL ITEM

ELECTION OF ACTING SPEAKER FOR THE 31 JANUARY COUNCIL MEETING

1. Purpose

The Purpose of this report is to request the Municipal Council to elect an acting Speaker to chair the Municipal Council meeting to be held on Monday, January 31, 2022.

2. Background

A. INVITATION TO ATTEND THE SALGA PROVINCIAL CONFERENCE JANUARY 31 TO FEBRUARY 01, 2022

Councillor Stefani Lockman-Naidoo has been invited to attend the Provincial SALGA Conference in Clarens, Free State on a two day program, starting from the 31 January and concluding on the 01st February 2022. The Speaker confirmed her attendance of this important activity and business of SALGA and hence a request for Council to elect an acting Speaker for the Municipal Council meeting which is a compliance Council meeting.

B. CRITICAL ROLE PERFORMED BY THE SPEAKER DUTING THE MEETING

Councillor Stefani Lockman-Naidoo, is the Municipal Council Speaker, and was duly elected on the 22nd November 2021. And as indicated above, she will not be in a position to attend and preside over the Municipal Council meeting scheduled for Monday, January 31, 2022. It is recommended that Council elect one member amongst the council members to act as the Speaker for the duration of the Council meeting. Critical issues for the Speaker during meetings, are as follows; namely

- Precedence at meetings. When the chairperson speaks, other councillors must remain silent.
- Flexibility: applying the rules and orders. The Speaker must have the power to influence and direct the proceedings of the meeting in an orderly and proper manner and enable each member an opportunity to debate matters in the agenda.

• Finality of the Speaker's ruling. When the Speaker makes a ruling during the meeting, it is final. There is no further debate on the issue especially after voting. This is not undemocratic but is to ensure that the proceedings of the meeting are not bogged down by disagreements on procedure.

It is clear that the role of the Speaker is critically important. We are highlighting the above critical roles the Speaker performs during the meeting.

3. FINALCIAL IMPLICATION

The will be no financial implications on the part of Council

4. LEGAL IMPLICATIONS

Structures Act section 36 Act (Act No. 117 of 1998), provides that if the Speaker is unable to attend the Council meeting, the Municipal Council should elect an acting Speaker for the duration of the meeting.

The above legal prescripts is provided to ensure that the business of Council is not held back due to the non-availability of the Speaker or Chairperson of Committees.

5. RECOMMENDATION:

It is hereby recommended that

- 1) the Municipal Council take note of the absence of the Speaker from 31 January until the 1st February 2022;
- the Municipal Council to elect one members from amongst Council members to act as the Speaker for the duration of the Council meeting scheduled for the 31 January 2022.
