RE: DEFERMENT OF COMPLIANCE WITH SECTION 16, 24 AND 28 OF THE MUNICIPAL FINANCE MANAGEMENT ACT: MANGAUNG METROPOLITAN MUNICIPALITY – 2022/25 MTREF ANNUAL BUDGET AND 2021/22 ADJUSTMENT BUDGET

Section 16 of the Municipal Financial Management Act stipulates that a municipality must approve an annual budget for the municipality before the start of the financial year.

Section 24 of the Municipal Financial Management Act stipulates that a municipal council must at least 30 days before the start of the budget year consider approval of the annual budget.

Section 28 of the Municipal Financial Management Act stipulates that a municipality may revise an approved annual budget through an adjustment budget.

The City approved the 2021/22 budget in May 2021, however as a result of new grants being received as per the DORA (Division of Revenue Act), there is a need to pass an adjustment budget in line with section 28 of the Municipal Finance Management Act. Further to that the City is unable to approve and adopt the annual MTREF 22/25 budget in line with sections 16 and 24 of the Municipal Finance Management Act. The City will be unable to meet the deadlines due to the following reasons:

- The municipality was without an accounting officer from 1 April 2022 until 20 April 2022.
- There was major disruptions, unrest, and instability during the last 2 months.
- A new national intervention team was appointed in the municipality on 20 April 2022, and they
  first needed to become familiar with the systems and operations of the city.
- Complaints from the DA, EFF, and other parties that they had insufficient time to make comments on the budget.

The City has developed an action plan in order to ensure that the Annual Budget and Adjustment Budget is adopted by Council on or before 3 June 2022 and 30 June 2022 respectively.

The municipality hereby informs the MEC for Finance (Free State Province) in terms of Section 27(3) of the Municipal Finance Management Act of the impending non-compliance with section 16(2) of the said Act and corrective measures that has been stated above.
