**Note by Secretariat**

Members are requested to fill in this register 12 hours before the commencement of the meeting (Rule 22.2) (Yellow Form).
3. **Name-plates:** Councillors are friendly requested to please take along their name-plates and to display it throughout the meeting.
4. **Apologies during the course of the Council meeting:** Councillors are friendly requested to complete in full and submit the relevant apology form for this purpose (Yellow Form).
5. **Code of Conduct:** Councillors are reminded of item 3, Schedule 1 of the Code of Conduct for Councillors which reads as follows, namely:

Attendance at Meetings: A councillor must attend each meeting of the municipal council and of a committee of which that councillor is a member, except when:

- (a) leave of absence is granted in terms of an applicable law or as determined by the rules and orders of the council or
- (b) that councillor is required in terms of this Code to withdraw from the meeting.

6. **Meeting rules:**

- i. All Councillors must arrive at **least 15 minutes before the commencement** of the Council and all other Committee meetings;
- ii. Cellular phones **must be in silent mode** and **speaking on a cellular phone during the meeting is prohibited;** (Rule 50.2a)
- iii. A Councillor who speaks must **confine his or her speech strictly to the matter under discussion;** (Rule 31)
- iv. Unless expressly otherwise determined, a Councillor **may speak only once on a matter;** (Rule 32)
- v. No speech shall exceed **five (5) minutes** in length without the consent of the Speaker. (Rule 34.1)
- vi. Council members are reminded to uphold high level of good conduct during Council proceedings (No disruptions, no interruptions, no howling, no swearing to other Council members, less movement in the Chamber, no abuse of the PA system).

**REQUEST FOR A SPECIAL COUNCIL MEETING TO INTRODUCE THE NATIONAL  
CABINET REPRESENTATIVE AND SUPPORT TEAM: MANGAUNG METROPOLITAN  
MUNICIPALITY**

The intervention by National Cabinet into the financial and service delivery crisis of the Mangaung Metropolitan Municipality refers.

Pursuant to the approval of this intervention by Cabinet on 06 April 2022, a process was undertaken to appoint a service provider to serve as the National Cabinet Representative whilst an interim intervention team was also deployed by National Government to assist the municipality. The National Cabinet Representative supported by a multi-disciplinary team of experts will manage the implementation of this intervention on behalf of Cabinet and ensure that Cabinet is at all times apprised of progress and challenges in this intervention.

The process to appoint the service provider has now been concluded and we would like an opportunity to formally introduce to the municipal council and the municipal administration, the team from Ntiyiso Consulting who will be led by Mr Paul Maseko as the National Cabinet Representative (NCR).

We therefore require your assistance in calling a Special meeting of Council for this Friday, 22 July 2022 at 10:00. The meeting will be held at your offices. We would also like to use this opportunity to induct council on some of the pertinent matters relating to this national intervention and the S139 intervention process in general, including a presentation on the extent of the prevailing crisis within the municipality.
