In response to the motion by both the Democratic Alliance and Freedom Front Plus

A. Failing duties according to the Municipal Structures Act - Part 3, ss 41(B)

- > It must come to the attention of this council that there no number of meetings that are determined to be held for Multiparty. The current situation warranted meeting to be arranged on the need basis and that has indeed happened. It won't be of any essence to call a meeting when there are no items that needs the attention of political parties.
- > There is a tendency from opposition parties to take matters of the Municipality and blow them out of proportion by providing the information that is meant for specific consultation to the media. It is for this reasons that the minutes of the Multi party will be circulated on request. To this far, there is no written request from any of the parties concerned who had formally and in writing requested the minutes. This is done to protect the already damaged reputation of the Mangaung Metro Municipality by leaking internal matters to the outside world without approval.
- > As the Chief Whip, I have ensured that every political party function properly and are accorded an office space. Arrangements had been made with the facilities department to allocate space to the P. A 's of political parties. A classical example is that one office allocated to African Christian Democratic Party. They were allocated the office as per their request. The Democratic Alliance had for past term been utilizing the office allocated to them in the City Hall Ground floor. Mr. Happy who works at facilities (Manager) did make them aware of the availability of the office they have previously been occupying, he had even indicated to them to make him aware when they will want to occupy it.
- > The appointment of Personal Assistants to political parties is the responsibility of the City Manager. The Council Whip does not engage himself/herself in the administrative matters

particularly matters of staff appointments. The Demecratic Allinance is playing its politics as normally they do. The P. A's were appointed temporarily for political parties during December month. This P.A 's is part of the political staff that you as the D. A went on media and said they are ghost workers and today you accuse the Council Whip of not ensuring that the P.A 's are appointed. It is in fact unscrupulous that you only care of your PA's not not other support staff in political office. However, it is understandable that you are not in governance but working hard to ensure that this Council collapse.

There has never been any meeting that was coordinated on short notice. The invitation to which you are referencing is in fact irrelevant to the Multiparty Whippery scheduled meetings. This is because the meeting was organized by the ministerial task team and they themselves, did that in a short notice. There was no reason to co-ordinate a meeting of that nature in fourty eight (48) hours when I did not even know there will be that kind of a meeting, that would be ridiculous to call a nonexistent meeting. The meeting was clear that it is an emergency in nature.

B. Failing duties according to the Municipal Structures Act – Part 3, ss 41B (C)

There has never been any multi-party meeting that deliberated on voting matters. All parties are invited to multiparty to discuss issues on the agenda and indeed they do as anticipated.

C) Failing duties in accordance to the Municipal Structures Act – Part 3. Ss 41B (D)
