REQUEST FOR COUNCIL APPROVAL FOR THE ESTABLISHMENT OF STRATEGIC RELATIONSHIPS WITH INSTITUTION OF HIGHER LEARNING IN THE MANGAUNG METROPOLITAN MUNICIPALITY (MMM) JURISDICTION.

## **Purpose**

To request Council approval for MMM to sign Memorandum of Understanding (MoU) with The University of Free State, Central University of Technology, and Motheo TVET College.

# **Background**

- The three institutions have operated, in their respective core function in the MMM jurisdiction for years, hence it could be confidently asserted that they are MMM key stakeholders.
- MMM had an MoU with Central University in the past, in 2016 and it was renewed in 2019. The
   MoU has since lapsed.
- MMM interaction and engagement with UFS and Motheo TVET has in the past been on an ad hoc basis and there was no coherence strategic engagement with these institutions.

### Motivation

- Successful and well governed municipalities, locally and internationally, have leveraged on the knowledge and research expertise institutions of higher learning provide.
- For example, University of KwaZulu Natal has an MoU with eThekwini Metro, Wits University has an MoU with the City of Joburg, City of Cape Town has a MoU with the consortium of institutions of Higher Learning in Cape Town and University of Pretoria has a MoU with the City of Tshwane.
- UFS, CUT and Motheo TVET are involved in community development projects within the Metro.
   Unfortunately, these activities are not coordinated and recorded.
- Research has proven that there are economic spin offs of having a university in a municipal
  jurisdiction, for example, there are job opportunities created and the tourism industry is boosted.
