RE: DEFERMENT OF COMPLIANCE WITH SECTION 28 OF THE MUNICIPAL FINANCE MANAGEMENT ACT: MANGAUNG METROPOLITAN MUNICIPALITY – 2022/23 ADJUSTMENT BUDGET

Section 28 of the Municipal Financial Management Act stipulates that a municipality may revise an approved annual budget through an adjustment budget.

Section 23(1) of the Municipal Budget and Reporting Regulations states that a budget referred to in section 28(2)(b), (d) and (f) of the Act may be tabled in the municipal council at any time after the mid-year budget and performance assessment has been tabled in council, but not later than 28 February of the current year.

The City approved the 2022/23 budget on 22 June 2022, however as a result of new revenues being received and other changes informed by mid-year performance, there is a need to pass an adjustment budget in line with section 28 of the Municipal Finance Management Act. The City was unable to meet the deadlines due to the following reasons:

- The current political instability in the institution.
- The mid-year performance assessment (Section 72) was only approved by council on 13 February 2023.

The City has developed a recovery plan in order to ensure that the Adjustment Budget is adopted by Council on or before 3 March 2023.
