SUBJECT: RESIGNATION AND REPLACEMENT OF COUNCILLORS

1. PURPOSE

- 1.1 The purpose of this report is to appraise the Mangaung Council on the resignation and replacement of councillors.

2. BACKGROUND AND DISCUSSIONS

- 2.1 The former Executive Mayor, Mr Mxolisi Siyonzana tendered his resignation on 27 February 2023 as propotional representative (PR) councillor representing the ANC and as the Executive Mayor of Mangaung Metro. On 14 March 2023, other resignation was tentered with immediate effect by former Speaker, councillor SB Lockman-Naidoo who resigned as PR councillor representing the ANC, and subsequent the Speaker of the Metro.
- 2.2 These resignations were with immediate effect on the date of resignation creating two (two) vacancies in council which were declared by the acting City Manager of the metro. The Municipal Structures Act makes provision for resignation of political office bearers and also provide mechanism for such replacements.

3. IMPLICATIONS

3.1 Financial

The Mangaung Metro is classified as a Category A Municipality and the municipal council of the metro is classified as Grade 6 as set out in Government Notice No. R 243 of March 25, 2015. The existing administrative resources and infrastructure to provide support to the councillors in executing their roles and responsibilities and including benefits of being elected as councillors is provided in Determination of Upper Limits of salaries and benefits for councillors determined annual by the Minister for CoGTA.

3.2 Legal

The Municipal Structures Act provide for the replacement of councillors that has since resigned in municipalities. The Independent Electoral Commission has processed the resignations of both Councillors in accordance with 18 of schedule 1 of the Municipal Structures Act, by declaring Mr. Gregory Mosala Solomon Nthatisi and Mr Bongani Lawrence Mathae on the 09 and 16 March 2023 respectively as duly elected councillors representing the African Congress on the PR lists. The effective date of their election commence from 09 March and 16 March 2023 and all the administrative processes regarding their elections had already been concluded.

The report is aimed to communicate the changes in pr councillors of the can in council.
