TABLING OF THE MANGAUNG METROPOLITAN MUNICIPALITY'S DRAFT REVIEWED INTEGRATED DEVELOPMENT PLAN (IDP) AS WELL AS DRAFTS SECTORAL PLANS (2023 – 2024) AND DRAFT SERVICE DELIVERY AND BUDGET IMPLEMENTATION PLAN (SDBIP) 2023/2024 FOR NOTING.

1. Purpose

To table the draft Integrated Development Plan (IDP) as well as draft sectoral plans and Service Delivery and Budget Implementation Plan for 2023 – 2024 for noting.

2. Background

Municipal Systems Act, Section 34 requires that: A municipal council-

- (a) must review its integrated development plan-
 - (i) annually in accordance with an assessment of its performance measurements in terms of section 4 i; and
 - (ii) to the extent that changing circumstances so demand; and
- (b) may amend its integrated development plan in accordance with a prescribed process.

This Act, as well as the Municipal Finance Management Act, 56 of 2003 further outlines the responsibility of the Executive Mayor in providing political guidance over the development of the IDP and the budget processes, and the identification of priorities that must guide the preparation of the annual budget. The review of the City's draft IDP for 2023/2024 was conducted in accordance with the IDP and Budget Process Plan that was adopted by Council as required by Regulation 21(1)(b) of the Municipal Finance Management Act.

Complementing the latter, sections 17 and 18 of Chapter 4 of the Municipal System Act, provides the means and mechanism for communicating key dates. As such, the city followed and utilized the Act to communicate with communities and other stakeholders, including internal structures to solicits inputs for the review of the IDP as required by law. In compliance with the above, the city solicited the inputs, comments using the available online platforms in the city, by press publications and through the submissions since August 2022 till to date. Moreover, the city held the physical Public Participation meetings during the months of February – April 2023.

Post the tabling of the draft IDP for noting, the city will continue to invite all participants and community members to comment and submit inputs as required by law

- Spatial Transformation
- (b) Economic Growth
