RE: DEFERMENT OF COMPLIANCE WITH SECTION 16 OF THE MUNICIPAL FINANCE MANAGEMENT ACT: MANGAUNG METROPOLITAN MUNICIPALITY – 2023/26 MTREF ANNUAL BUDGET – CHANGE OF EXPECTED FINALISATION DATE

The letter dated 14 April 2023 refers.

From this correspondence we requested the honourable MEC for Finance to condone the non-compliance of the timeframes for the tabling of the annual budget. At that time, it was expected that the Executive Mayor would have been appointed by then and therefore condonation was only requested until Friday, 28 April 2023 for the tabling of the annual budget.

The expected finalisation date for the tabling is no longer possible due to the following reasons:

- Despite council meetings originally scheduled for Thursday, 6 April 2023 as well as Wednesday, 12 April 2023 to appoint the Executive Mayor, they were unable to materialise due to the following reasons:
 - Allegations of threats and intimidation from and against councillors.
 - Unrest from workers regarding issues of overtime and not allowing councillors to attend the council meeting.
- Current political instability in the municipality.

A council meeting had been scheduled for Tuesday, 25 April 2023 whereby the Acting Executive Mayor was successfully appointed. That did however, not allow sufficient time for the Acting Executive Mayor to properly ventilate and assess the budget which would

not be possible by 28 April 2023. The rules of Council also requires at least 48 hours notice period.

The municipality does not expect a material impact on the remaining legislated processes and/or other MFMA timelines, however there might need to be a request to condone non-compliance of the timelines with regard to the submission of the annual budget for approval by council in terms of section 24 of the MFMA ("a municipal council must at least 30 days before the start of the budget year consider approval of the annual budget"). That would however be managed and would only be applicable if no other measures are available.

It is for these reasons that the municipality requests a further condonation to table the annual budget to at least Tuesday, 2 May 2023.

There would also be a delay by about 32 days in terms of the Public participation process. That would however be managed and would only be applicable if no other measures are available.

The process of finalising the annual (MTREF) budget was impacted and delayed by the following reasons:

 The current political instability in the institution due to the vacancies of the Speaker and Executive Mayor. (The Speaker was only elected at the council meeting of 29 March 2023 and the Acting Executive Mayor was appointed on 25 April 2023 which have left insufficient time to convene a meeting for the tabling of the annual budget).
