APPROVAL OF MANGAUNG METROPOLITAN MUNICIPALITY DISTRICT DEVELOPMENT MODEL ONE PLAN

Purpose

To seek Council approval of Mangaung Metropolitan Municipality District Development Model One Plan (DDM One Plan)

Background

- Cabinet approved the DDM in August 2019.
- The DDM is an all-of -government approach to improve integrated planning and delivery across the three spheres of government.
- The DDM is aimed at facilitating integrated planning, delivery, and monitoring of government's development programmes through the concept of a Joint "One Plan" in relation to 52 development spaces.
- A draft One Plan was developed and submitted to National Cogta on 31 March 2021.
- There was a Council submission and resolution on the draft One Plan on 29 June 2021 with the resolution for:
 - Noting of the One Plan submitted to National Cogta.
 - Approved establishment of Political IGR to be chaired by Executive Mayor.
 - Approved establishment of Technical IGR to be chaired by City Manager with various technical work streams.
- The Council adopted the One Plan in its sitting of 30 June 2022.

 The One plan was then shared with National Cogta, FS Cogta and FS Office of the Premier (OTP) DDM coordinators.

Discussion

There were areas and gaps identified in the One Plan submitted that needed to be addressed and these areas are:

1. Statistics and Demographics

It is true some of the statistics which were in the submitted One Plan were dated and as such, were not useful for planning purposes. With the help of National Cogta, STATSSA and FS OTP, recent stats were provided and MMM could update her stats information,

2. Consultation with Stakeholders

Members of the National DDM Quality Assurance concern was that the One Plan submitted omitted inputs from several stakeholders and the MMM DDM office rectified this by engaging these stakeholders accordingly.

- Association of the Society with People with Disabilities
- Institutions of Higher Learning. The Council has since approved the strategic establishment of relationships with these institutions.
- A soft copy of the One Plan was shared with the Government Sector departments to make further inputs.
- A meeting was held with the Barolong Boo Seleka Traditional House in Thaba Nchu. It worth mentioning that Kgosi Moroka is well au faire with the government DDM approach and is committed to work collaboratively with MMM.
- Meetings were held with Ward Committees in Thaba Nchu, Wepener, Botshabelo and Bloemfontein. The engagements were successful in so far as receiving new inputs for the One Plan.
