TEMPORARY RELOCATION OF Phase 4 COMMONAGE (BLOEMFONTEIN) TO RE/109 AND 175 LAKEVIEW MUNICIPAL PLOTS (BLOEMFONTEIN).

1. Purpose

To seek council approval to temporary, utilize RE/109 Bardenstraat plot,175 Oranjestraat Lakeview Bloemfontein owned by the Mangaung Metropolitan Municipality for the translocation of Phase 4 Commonage.

2. Strategic intent

Poverty reduction, job creation, rural and economic development.

3. For decision/consideration by

Section 80 Committee on Rural Development/ Mayoral Committee/ Council.

4. Introduction and background

There is currently a court order (See Annexure 1) that compels Mangaung Metropolitan Municipality to institute appropriate legal proceedings alternatively take other appropriate action to demolish and remove all structures illegally constructed and/or erected at the municipal land, zoned to be residential area situated at Erf 8132 Phase 4, Bloemside, Bloemfontein. The Municipality is currently unable to commence with the appropriate legal proceedings for the eviction of the illegal occupiers to be relocated from Erf 8132 Phase 4, Bloemside, Bloemfontein because the Municipality still have, by law, the obligation of providing illegal occupiers with alternative place for accommodation.

There is a growing need and demand by community members across the seven geographic towns of the city for agricultural land to enable their entrance into the

agricultural sector and livelihoods protection. This growing trend has led to small scale farmers having their livestock within or near residential areas. This development poses serious traffic, health, and hygiene risks to members of the community and as a responsive municipality a permanent solution must be sought to avoid potential social conflict and litigation by community members.

It is therefore critical that the exercise referred to above be undertaken to identify the Municipal land to which the illegal occupiers could be relocated when they are moved from Erf 8132 Phase 4, Bloemside, Bloemfontein and more broadly to identify similar land in all seven mangaung towns so that a comprehensive and long-term solution is sought for the whole of the city.

5. Proposed land for the relocation

In consideration of the conditions and administration of the current Phase 4 Commonage, the number and different livestock, it is proposed that the Phase 4 Commonage be relocated 109 Bardenstraat plot,175 Oranjestraat Lakeview Bloemfontein. Lakeview plot RE/109 (4,2816) ha, plot 175 (4,2816) ha. In extent that will potentially accommodate the relocated livestock, also included is the locality map.

6. Current Conditions and Space Summaries

The current conditions justification for relocating intervention are:

- Structures in the commonage are derelict and not built to the standard.
- The animals will primarily be in pasture conditions.
- Utilization of appropriate land mass to accommodate relocated livestock.
- Improved livestock health.
- Improved livestock farming function and improved public perception.

7. Financial Implication

There will be no financial implication to the Municipality.



8. Recommendation

The Council approved the temporary relocation of Phase 4 Commonage in Bloemfontein to RE/109 Bardenstraat plot,175 Oranjestraat Lakeview Bloemfontein. Consisting of approximately 11 owners with a total 182 small livestock, at no cost to the municipality.

- 1. That all livestock be relocated to Lakeview and SPCA determine if any livestock is not suffering from contagious disease or may prove dangerous to human life.
- That any livestock found to be contagious disease or prove dangerous to human life be impounded by SPCA and dealt with in accordance with the provisions of the Keeping of Animals, Poultry and Bees By-Law (as promulgated by Local Government Notice No. 35 of 24 June 2016) and the Animal Diseases Act, (Act no. 35 of 1984).
- 3. That the identified municipal smallholdings be utilized for livestock farming and commonage purposes only.

I, the undersigned,

hereby state under oath as follows:

1.

- 1.1 I am an adult male currently residing at Erf 8134, Heidedal, Phase 4, Bloemside, Bloemfontein, Free State Province.
- 1.2 I am the Applicant in the application and the facts contained herein falls within my own personal knowledge which I confirm as true and correct unless otherwise indicated.
- 1.3 Where I make legal submissions I do so on the advice of my legal representatives which advice is accepted.

- 2.1 The 1st Respondent is the Mangaung Metropolitan Municipality, a Metropolitan Municipality with legal personality duly established in terms of the Statutes of the Republic of South Africa with offices situated at Bram Fischer Building, 5 De Villiers Street, Bloemfontein, Free State Province.
- 2.2 The 2nd Respondent is the Municipal Manager of the Municipality in his capacity as the head of administration of the 1st Respondent at Bram Fischer Building, 2nd Floor, 5 De Villiers Street, Bloemfontein, Free State Province and as such the accountable Officer tasked with overseeing and implementation of Court Orders against the 1st Respondent.

PURPOSE OF APPLICATION:

4.

The purpose of this application is to find the 1st and 2nd Respondents in Contempt of Court as a consequence of non-compliance with **Annexure** "A" hereto and to be sentenced accordingly. In terms of Annexure "A"

- "1. The First Respondent is compelled to institute appropriate legal proceedings alternatively take other appropriate action to demolish and remove any and all structures illegally constructed and or erected at the municipal grounds directly opposite the Applicant's property situated as Erf 8134 Heidedal, Phase 4, Bloemside, Bloemfontein, within 30 days of this order.
- 2. The First Respondent is compelled to institute appropriate legal proceedings alternatively take other appropriate action in order to remove any and all livestock kept at the municipal grounds directly opposite the Applicant's property situated at Erf 8134 Heidedal, Phase 4, Bloemside, Bloemfontein, within 30 days of this order.
- 3. The First Respondent is to pay the costs of this application."

The Court Order Annexure "A" was duly and properly served upon the 1st and 2nd Respondents by the Sheriff of the Honourable Court, which service was effected on the 16th of May 2022 upon Ms S Brown, Legal Services, at the offices of the 1st Respondent. True copies of the Notices of Service aforementioned are annexed hereto as **Annexures** "B1" and "B2".

After the 1st and 2nd Respondents failed to comply with the Court Order, Annexure "A" hereto, my Attorneys of record addressed a letter to the Legal Department of the 1st Respondent and



which was delivered to them by hand on the 8th of July 2022, a true copy of which is attached herewith as **Annexure** "C".

6.

In terms of the contents of Annexure "C" the 1st Respondent was requested to confirm as to whether or not they started with the necessary legal proceedings alternatively as to inform my Attorneys of record as to when they will start with the legal proceedings in which their reply was expected within 7 (seven) days of date of the letter by default of which the Court would be approached for an Application of Contempt of Court. No reply was received by my Attorneys of record on the aforementioned letter, Annexure "C".

7.

In a further attempt to request the 1st Respondent to comply with the Court Order, Mr Henco Erasmus, who is a Candidate Attorney at the office of my Attorneys of record personally attended the 1st Respondent's Legal Department and he was informed by the Receptionist to send an email to Mr Paul Monama at paul.monama@mangaung.co.za who will then reply to the enquiries. Consequently my Attorneys of record addressed an email to Mr Monama in terms of which the courtesy of a response is required and further in terms of which it is confirmed that the Applicant intends to approach the Court for an Application of Contempt of Court. A true copy of this email is attached herewith as Annexure "D". No reply was however received by either Mr Monama or any other official of the 1st Respondent.

8.

In the meantime the bill of cost was taxed in terms of the Cost Order granted in terms of Annexure "A" and failing payment the Sheriff of the Honourable Court on the 17th of August 2022 attached the bank account of the 1st Respondent and supplied the 1st Respondent with a copy of the Notice of Service. A true copy of the Notice of Service is attached hereto as Annexure "E".

I humbly submit that following the aforementioned it is very clear that the 1st and 2nd Respondents received more than sufficient notice and request to comply with the Court Order. No reply of any sort is however communicated to my Attorneys of record. The 1st Respondent has to date hereof not complied or even attempted to comply with the Court Order, Annexure "A".

10.

The main application was brought by myself mainly as the actions of the 2nd and 3rd Respondents in the main application posed a serious health risk which is still the case. The purpose of that Application further was to stop the 2nd and 3rd Respondents in the main application to act illegally, their illegal actions still continue uninterrupted. I am being terribly prejudiced by the non-compliance by the 1st and 2nd Respondents in this Application for not complying with the Court Order.

11.

I have been advised that once the Applicant has proved the order, service or notice of the said Order, and non-compliance, the Respondents bear an evidentiary burden in relation to wilfulness and mala fides.

12.

I respectfully submit that all the requisites of contempt have been proven. The Court Order exists and was served and came to the intention of the 1st and 2nd Respondents.

13.

Wherefore I humbly request the Honourable Court to grant an Order in terms of the Notice of Motion duly annexed hereto.
