### **TABLING OF THE MANGAUNG METROPOLITAN MUNICIPALITY'S 2023 – 2024 REVIEWED INTEGRATED DEVELOPMENT PLAN (IDP) AS WELL AS SECTORAL PLANS (2023 – 2024) FOR APPROVAL.**

#### **1. Purpose**

To table the reviewed Integrated Development Plan (IDP) as well as sectoral plans for 2023 – 2024 for approval.

#### **2. Background**

Municipal Systems Act, Section 34 requires that: A municipal council—

(a) must review its integrated development plan—

(i) annually in accordance with an assessment of its performance measurements in terms of section 4 i; and

(ii) to the extent that changing circumstances so demand; and

(b) may amend its integrated development plan in accordance with a prescribed process.

This Act, as well as the Municipal Finance Management Act, 56 of 2003 further outlines the responsibility of the Executive Mayor in providing political guidance over the development of the IDP and the budget processes, and the identification of priorities that must guide the preparation of the annual budget. The review of the City's IDP for 2023/2024 was conducted in accordance with the IDP and Budget Process Plan that was adopted by Council as required by Regulation 21(1)(b) of the Municipal Finance Management Act.

Complementing the latter, sections 17 and 18 of Chapter 4 of the Municipal System Act, provides the means and mechanism for communicating key dates. As such, the city followed and utilized the Act to communicate with communities and other stakeholders, including internal structures to solicit inputs for the review of the IDP as required by law. In compliance with the above, the city solicited the inputs, comments using the available online platforms in the city, by press publications and through the submissions since August 2022 till 23 May 2023. Moreover, the city held the physical Public Participation meetings during the months of February – May 2023.

Post the tabling of the draft IDP for noting, the city invited all participants and community members to comment and submit inputs as required by law.

Lastly, the review of the IDP (2023 – 2024) continue to be led by the vision of the city ‘... globally safe and attractive to live, work and invest in’ and further endorsed by the five **Strategic IDP Development Objectives** namely:

- (a) *Spatial Transformation*
- (b) *Economic Growth*
- (c) *Service Delivery Improvement*
- (d) *Financial Health Improvement*
- (e) *Organisational Strength*

### 3. Recommendations

The recommendations are that the Council:

- 1) approves the reviewed Integrated Development Plan for 2023/2024;
- 2) approves the below mentioned Sector Plans for 2023/2024 (Annexures as Key Components of IDP);
