SUBJECT: REPLACEMENT OF WARD COUNCILLORS AT WARD 7, 29, 49 AND 50 - BY ELECTION HELD ON 19 JULY 2023.

1. PURPOSE

1.1 The purpose of this report is to appraise the Council on the outcome of the by elections that took place at ward 7, 29, 49 and 50 on 19 July 2023 by the Independent Electroral Commission.

2. BACKGROUND

2.1 The Municipal Structures Act (Act No. 117 of 1998) allows that by elections must be held in an event vacancies arose in a ward after declaration of such vacancies by the by the MEC responsible for local government. Subsequent thereto, on 18 April 2023, the Honourable MEC MK Makume in consultation with the Electoral Commission proclaimed and gazetted that the by elections in ward 7,29,49 and 50 will take place on 19 July 2023.

3. DISCUSSION

3.1 The Electoral Commission conducted the by elections on 19 July 2023 in ward 7, 29, 49 and 50. The results of the by elections was that the ANC retained the wards and the contenders were declared elected as ward councillors for ward 7, 29, 49 and 50 at Mangaung Metropolitan Municipality, as prescribed in Item 18 of Scheduled 1 of the Municipal Structures Act, 1998 (Act No. 117 of 1998). 4. IMPLICATIONS
