#### 1. PURPOSE

1.1 The purpose of this report is to request the Municipal Council to approve the annual programme, schedule of meetings of Mangaung Metropolitan Municipality for the forthcoming 2023/2024 financial year (July 2023 to June 2024).

## 2. BACKGROUND

- 2.1 In accordance with the provisions of Municipal Structures Act read in conjunction with the Rule 4 of the Council's Standing Rules and Orders, the Speaker as the Chairperson of the council has to determine a schedule of the dates, times and venue of the ordinary meetings of Council for the period of twelve months, in advance taking into account that at least one ordinary Council meeting held on quarterly basis.
- 2.2 The intent is to enhance planning and also assist the administration to prepare well in advance, the reports, agenda and any other matter thereon as the Municipal Manager with regard to the Council/ Committee meetings is expected to give notice of at least 48hours prior to the meeting or last workday before the meeting in accordance to the Standing Rules and Orders Rule 5.1 and 6.1 and thus enabling the Council or Committee members to prepare timeously for the meetings.

### 3. DELIBERATIONS

- 3.1 The programme schedule of meetings of council is a strategic diary for all municipal employees and councillors to improve coordination of council meetings, document processing and decision making from executive management, committees of council for tabling to council.
