SUBJECT: ELECTION OF THE COUNCIL WHIP

### 1. PURPOSE

1.1 The purpose of this report is to elect the Council Whip for the Mangaung Metropolitan Council in terms of Section 41A of the Local Government: Municipal Structures Act, Act 117 of 1998 (herein after referred as the "Structures Act").

### 2. BACKGROUND

2.1 The Mangaung Metro is a Category A Municipality with a Mayoral Executive System as contemplated in Sections 7 and 9 of the Structures Act, The Mayoral Executive System allows for the exercise of the executive authority through an Executive Mayor in whom the executive leadership of the municipality is vested and who is assisted by a Mayoral committee.

### 3. DISCUSSION

3.1 On 25 April 2023, council in terms of council resolution 62.2 – 25/4/2023 designated Cllr Vumile Edwin Nikelo to act as Council Whip, after seven (7) former councillors were expelled by their own political party triggering declaration of seven (7) vacancies on 18 April 2023 by the MEC of CoGTA in the province. Subsequent thereto, PR list of the affected party was updated, replacements made with three (3) councillors declared elected on 20 April 2023 by the Electoral Commission. Further thereto, the Electoral Commission conducted the by elections on 19 July 2023 to fill the four (4) ward

vacancies as published in the General Notice 183 of 2023 of the Electoral Commission and published in Provincial Gazette No. 08 of 2023.

3.2 The outcome of the by election were announced and new ward councillors were then declared elected on 21 July 2023. To that end, as things stands in the municipality, there are no impediment to the Municipal Council electing permanent leadership, including the Council Whip to ensure political instability subsides and different political parties represented in council work in cohesion and harmony with common goal of provision of services and improving service delivery to communities. It is therefore recommended that council elects the Council Whip to assist the Speaker in maintaining order and decorum during council meetings, forging sound relations between political parties and resolve any disputes that may arise between political leadership in the municipality.

### 4. LEGISLATIVE PROVISIONS

Schedule 3 of the Structures Act, prescribes the below-mentioned procedure to be followed when electing Council Whip -: namely

### (a) Nomination

 The person presiding at the meeting must call for the nomination of candidates.

### (b) Formal Requirements

- A nomination must be made on the form determined by the Municipal Manager;
- The form on which a nomination is made must be signed by two members of the Municipal Council; the proposer and seconder;
- A person who is nominated must indicate acceptance of the nomination by signing either the nomination form or any other form of written confirmation.

### (c) Announcement of names of candidates

 At a meeting to which this schedule applies, the person presiding must announce the names of the persons who have been nominated as candidates but may not permit debate.

### (d) Single candidates

 If only one candidate is nominated, the person presiding must declare that candidate elected.

### (e) Election procedure

If more than one candidate is nominated -

- (i) a vote must be taken at the meeting by secret ballot;
- (ii) each councillor present at the meeting may cast one vote; and
- (iii) the person presiding must declare elected the candidate who receives majority of the votes.

### (f) Elimination procedure

If no candidates receive a majority vote, the candidates who receives
the lowest number of votes must be eliminated and a further vote taken
on the remaining candidates in accordance with item 6. This procedure
must be repeated until a candidate receives most of the votes.

### 5. **DELEGATIONS**

5.1 The delegations to the Council Whip are defined in the Structures Act.

### 5. IMPLICATIONS

### 5.1 Financial

Council Whip is elected and appointed as full-time councillor and his or her salaries and benefits are defined and provided in *Determination of Upper Limits of salaries* and benefits for councillors determined annually by the Minister for CoGTA.

### 5.2 Legal

The election of the Council Whip must be through a secret ballot.

### 5.3 Community & Service Delivery

Urgent filling of the vacancy of the Council Whip in accordance with the legislative requirements is crucial to ensure harmony and compliance with tabling of compliance by the City of Mangaung.

### 6. RECOMMENDATION

6.1 It is recommended that Council take note of the report and elect one councillor to serve as the Council Whip on a full-time basis.
