**RESPONSE TO RULE 38 QUESTION: INCOMPLETE TOILETS IN THABA-NCHU,
SELOSESHA EXTENSION 3, WARD 40 SINCE 2012.**

Question 1:

Is MMM aware that sewerage toilets build since 2012 in Selosesha ext 3 are still incomplete (not flushing)?

Response: Yes, because a loco inspection of the whole was conducted to establish the extent of the problem.

Question 2:

Who was the contractor, and how much was budgeted for the project?

Response: WK Construction was appointed for the project. Project Number was W1416 G, 12 May 2015. Cost R 48 749 747.72 (vat exclusive)

Question 3:

Is MMM aware that residents that are flushing connected themselves illegally?

Response: This was not observed during the loco inspection alluded to above.

Question 4:

When is MMM going to attend to this very urgent Human Rights matter?

A sewer refurbishment Consultant was requested to investigate the extent of the problem on site, which culminated in the Report obtained.

Bigen Africa was also conducting water pressure investigations in an unrelated Water Demand exercise.

The intention is to use the two reports to further evaluate the problem and come up with an appropriate effective solution.

The project was not budget for in the current and previous financial years, however a possibility of engaging a Sewer Refurbishment Contactor was discussed internally to resolve the matter.
